**Start Time:** Trials will start at 9:00 AM and the facility will open one hour prior. Check in will start at 8:00 AM. General Briefing will start at 8:45 AM. The facility will close 1 hour after the trial ends.

BGDS reserves the right to change the start time of the trial in the final confirmation due to weather conditions. Please check the Facebook group if there is any question.

Judge of Record and Event Official dogs may be judged prior to the official start time or as the first blind(s) of the Event.

Entries will be accepted in order of receipt. All entries must be accompanied by entry fees and a correct BHA number to be valid. There will be a \$50.00 fee for all returned checks. Late entries and Day-of entries will be accepted if the trial does not fill. Late and/or Day of Show entries are not a guaranteed entry and will be accepted only up to Judging limits. Confirmations will not be sent for Late entries. **NEW DAY OF ENTRIES must be made BEFORE the trial starts for the day** 

**Move Ups:** Move-ups, down or laterally will be accepted between days and between trials as class order allows. Dogs will be limited to 2 moves per event weekend.

You are responsible for knowing the <u>BARN HUNT RULES</u>. The judge, secretary, trial chair, or any volunteers are responsible for telling you the rules and what will result in a Non-Qualifying score.

#### **Exhibitor Information**

Dogs must be leashed or crated when not actively working. Please pick up after your dog and dispose of waste in appropriate containers outside the building.

**Trial Grounds:** Trial grounds all property of Tin Woof Inn and surrounding businesses. The bathrooms are in the main kennel building you can enter through the main doors or through the doors across from the inground pool. Only the doors across from the pool will be open when the business is closed.

**Ring Description:** The ring 1 is on matted concrete with two sides of metal kennel fencing and 2 sides barn walls.

Blinds: The blinds will be inside at least 10x20.

**Safety:** At all times, the safety of the dogs, handlers, and rats is to be of paramount importance. Rats will be humanely handled, and confined safely in aerated PVC tubes; Barn Hunt is not intended to harm or kill rats.

**Crating:** Exhibitors may crate out of their vehicles or in the barn as space allows.

**Leashes and Collars:** Electronic collars/devices are not allowed. Limited slip martingale and single piece slip collars/leads are allowed. Harnesses are allowed.

Dogs may not be brought to the gate in any disallowed collar. Dogs MUST run "naked," without a collar/harness. Dogs should be brought to the ring with collars/harnesses which can be easily and quickly removed and replaced.

**Bitches in season:** Are eligible for entry but will be required to be kept separate from all other dogs and will run at the end of their class/trial. Entry fees for bitches that come into season will be refunded until the closing time if you wish to withdraw. If bringing a bitch in season, please inform the trial secretary prior to the trial and inform all exhibitors at the general briefing.

**Refunds:** No event fee will be refunded if the event cannot open or be completed by reason of riots, civil disturbances, fire, and act of God, public emergency, act of a public enemy, or any other cause beyond the control of the event committee. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee. Refunds are ONLY allowed if requested before the closing date.

**Food Services:** There are fast food restaurants within 5-10 minutes of the trial. We may be doing a potluck depending on regulations at the time. Watch your confirmation for more information.

**RV's/Trailers**: Please contact the trial secretary to reserve an RV spot.

**Payment and Forms**: All entry forms are required to have all information completed including the Barn Hunt number, CORRECT NAME, height; signature, etc. Payment must be sent at the same time. Incomplete forms, nonpayment and returned checks do not constitute a valid entry fee. There is a \$50.00 returned check fee. Entries may be done via our online form or hard copy mailed. No emailed entries accepted.

**Awards:** Ribbons will be awarded for all qualifiers in the regular classes and the Instinct Test. Ribbons will be awarded for first through fourth place in Novice through Master. Title ribbons will also be provided. Special Awards may also be provided.


#### **Liability Waiver**
