**Start Time:** Trials will start at 9:00 AM (briefing at 8:45) and the facility will open one hour prior. BGDS reserves the right to change the start time of the trial in the final confirmation due to weather conditions. Please check the Facebook group if there is any question.

Classes offered each day: Trial 1: Instinct, Novice, Open, Senior, Masters, Crazy 8's Trial 2: Instinct, Novice, Open, Senior, Masters, Crazy 8's. There will be a lunch break at the judge's discretion. Class order will be announced in the final confirmation.

Entries will be accepted in order of receipt. All entries must be accompanied by entry fees and a correct BHA number to be valid. There will be a \$50.00 fee for all returned checks. Late entries and Day-of entries will be accepted if the trial does not fill. Late and/or Day of Show entries are not a guaranteed entry and will be accepted only up to Judging limits. Confirmations will not be sent for Late entries. **DAY OF ENTRIES must be made BEFORE the trial starts for the day** 

**Move Ups:** Move-ups will be accepted between days every day and between trials *as class order allows*. Lateral moves from the A level of a class to the B level of the same class will be accepted between trials. According to the BHA rules you cannot move down during an event.

## **Exhibitor Information**

Dogs must be leashed or crated when not actively working. Please pick up after your dog and dispose of waste in appropriate containers outside the building.

**Trial Grounds:** Trial grounds all property of Tin Woof Inn and surrounding businesses. The ring is on matted concrete with two sides of Lattice Fencing and 2 sides barn walls. The blinds will be dependent on the weather either under the overhangs outside of the barn or under enclosed tents inside of the barn. The barn is climate controlled.

**Safety:** At all times, the safety of the dogs, handlers, and rats is to be of paramount importance. Rats will be humanely handled, and confined safely in aerated PVC tubes; Barn Hunt is not intended to harm or kill rats.

Crating: Exhibitors may crate out of their vehicles or in the barn.

**Leashes and Collars:** Electronic collars/devices are not allowed. Limited slip martingale and single piece slip collars/leads are allowed. Harnesses are allowed. Please read the BH rulebook regarding allowed collars to avoid breaking those rules

**Collars in the Ring:** Dogs may not be brought to the gate in any disallowed collar. Dogs MUST run "naked," without a collar/harness. Dogs should be brought to the ring with collars/harnesses which can be easily and quickly removed and replaced.

**Bitches in season:** Are eligible for entry but will be required to be kept separate from all other dogs and will run at the end of their class/trial. Entry fees for bitches that come into season will be refunded until the closing time if you wish to withdraw. If bringing a bitch in season, please inform the trial secretary prior to the trial and inform all exhibitors at the judge's briefing.

**Refunds:** No event fee will be refunded if the event cannot open or be completed by reason of riots, civil disturbances, fire, and act of God, public emergency, act of a public enemy, or any other cause beyond the control of the event committee. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee. Refunds are ONLY allowed if requested before the closing date.

**Food Services:** There are limited fast food restaurants within driving distance from the event location. We will do pot lunch lunches daily.

**Payment and Forms**: All entry forms are required to have all information completed including the Barn Hunt number; height; signature, etc. Payment must be sent at the same time. Incomplete forms, nonpayment and returned checks do not constitute a valid entry fee. There is a \$50.00 returned check fee

**Awards:** Ribbons will be awarded for all qualifiers in the regular classes and the Instinct Test. Ribbons will be awarded for first through fourth place in Novice through Master. Title ribbons will also be provided. Special Awards may also be provided.

**Volunteers**: Volunteers are always helpful and appreciated.

### **Liability Waiver**

I (we) agree that Bluegrass Dog Sports has the right to refuse this entry for cause which the club shall deem sufficient.
